THE IMPACT OF SIRE

Steven's Story

One lovely spring day, SIRE instructors introduced Steven to Jet the horse. It would be a meeting neither party would soon forget, and one that would start Steven off on his journey to build his strength and confidence with the help of his new friend.

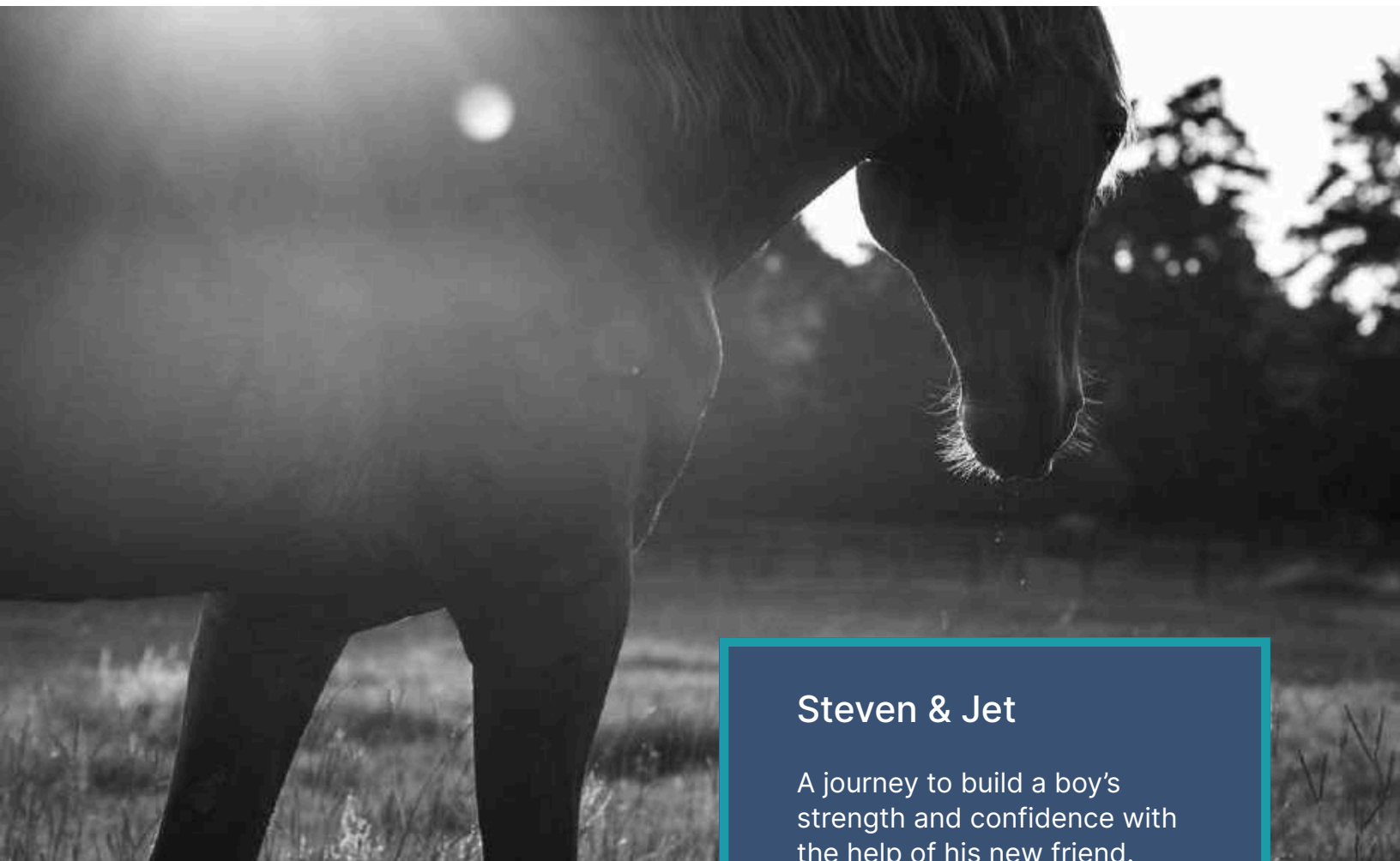
Steven, who spends most of his time in a wheelchair, is diagnosed with cerebral palsy, which causes a loss or deficiency of motor control. When Steven first met Jet, he was anxious, but that negative feeling would soon be relieved as Jet nuzzled Steven, as if to say, "I am here for you, and it will be okay." After only his first few lessons, Steven began to change: his parents noticed he was sitting up straighter in his wheelchair and could move more easily to his walker when needed. Six months later, Steven was riding Jet with very little assistance, building his core strength, and even won three medals at the Special Olympics Equestrian Competition in 2018.

Just as important as these wonderful physical gains are the improvements in Steven's social



and emotional health. Steven now has a group of friends he rides with every week (both human and horse friends), and his attitude at school has improved with each week of riding time. In fact, Steven loves riding at SIRE so much that his parents can use riding at SIRE as the carrot to get chores done at home.

It takes both our talented instructors and wonderful horses working together to bring these fun and engaging activities to people like Steven, and it goes to show that with a little patience, and the love of a horse, that lives are changed every day at SIRE Therapeutic Horsemanship.

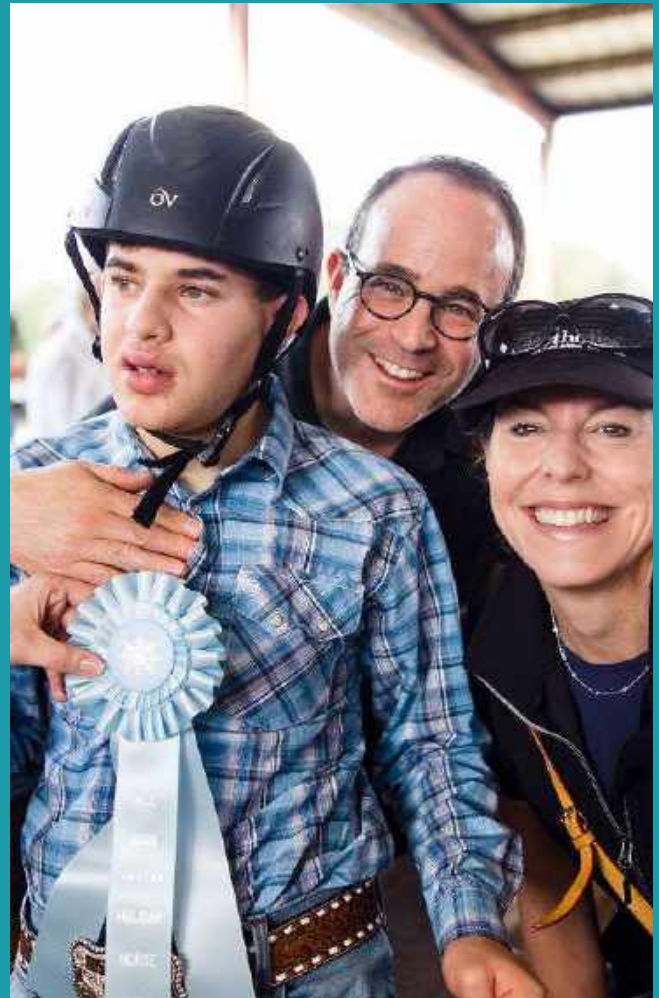
Meet Pierre!



Born in 2006, Pierre spent most of his time working as a hunter jumper competitor. It wasn't until 2021 that Pierre retired from his competing years and joined SIRE as a therapy horse. Despite his short time with SIRE, he has quickly become a rider favorite due to his friendly and playful demeanor.

Pierre is a thoroughbred gelding, and his coat is Flea Bitten Grey. Did you know that Pierre's coat color is special in that his coat pattern did not appear until he was older? Flea Bitten Grey is rare because it looks ordinary at first, having a chestnut or bay base when the horse is born, but as it ages the coat starts changing its color to gray-ish white.

Beautiful horses like Pierre work with our clients throughout the year and make wonderful memories that will last a lifetime. It costs over \$5,000 per year to feed, house, train and maintain proper health for a horse like Pierre. Throughout FY2023, generous support from our donors has allowed SIRE to maintain a herd of over 30 horses to work with the hundreds of people SIRE serves every week.

Description of the plan to measure and evaluate results –

Clients are surveyed each May for outcomes. Outcomes similar to those shown below for the next period ending in May 2024 are anticipated. Since many of the benefits of therapeutic riding transfer to the home, school, or workplace, SIRE believes that a survey is the best way to measure the outcomes. The complete outcomes survey includes a total of 27 questions.

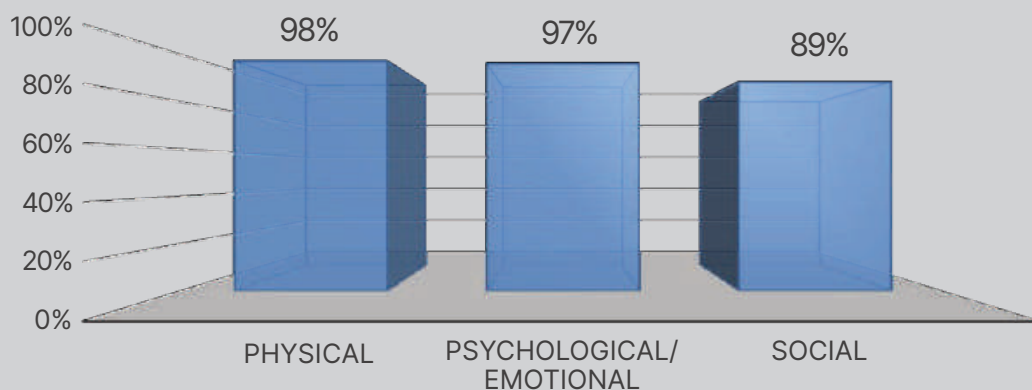
The following are the high-level results of our May 2023 Client Outcomes Survey:

- 98% have benefited physically from riding.
- 97% have benefited emotionally or psychologically from riding.
- 89% have benefited socially from riding.
- 79% SIRE has been the best activity of all the various therapies and activities they have tried.

100% say that SIRE has benefited them either physically, emotionally/psychologically, or socially.

52% completed the survey.

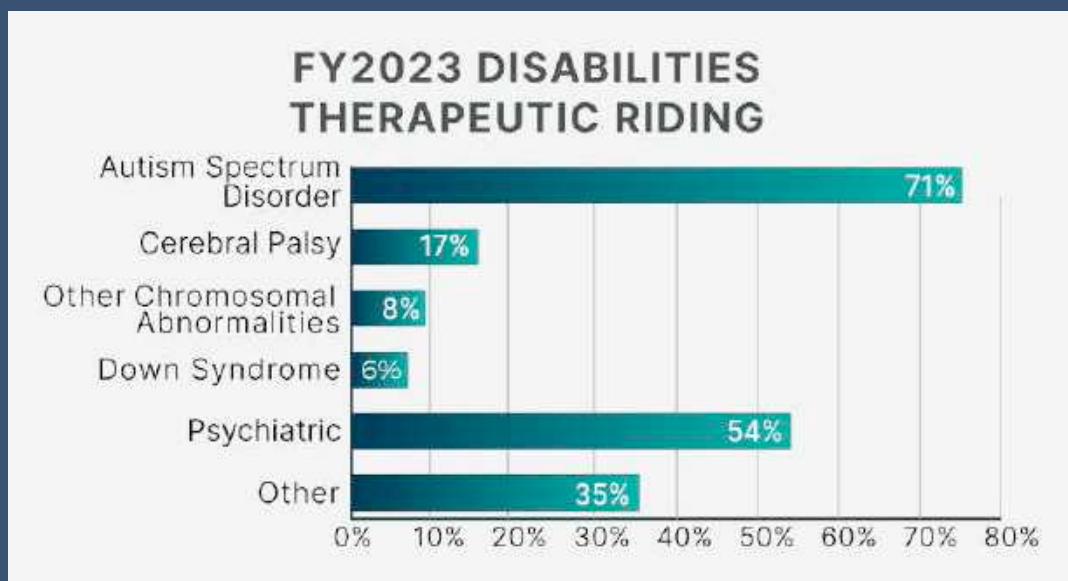
Benefits of Therapeutic Riding at SIRE 2022-23 with 52% of riders reporting

Program Highlights

SIRE provided over 6800 service hours to 302 unduplicated clients through a combination of our weekly Therapeutic Riding (TR) program (159 clients, 4510 hours), the Equine-Assisted Learning (EAL) program (67 students, 720 hours), the veterans program (76 clients, 728 hours), and the competition program. From our annual survey, 100% report they benefited physically, emotionally/psychologically, or socially from Therapeutic Riding, and 79% of clients report that SIRE has been the best activity of all the various therapies and activities they have tried.

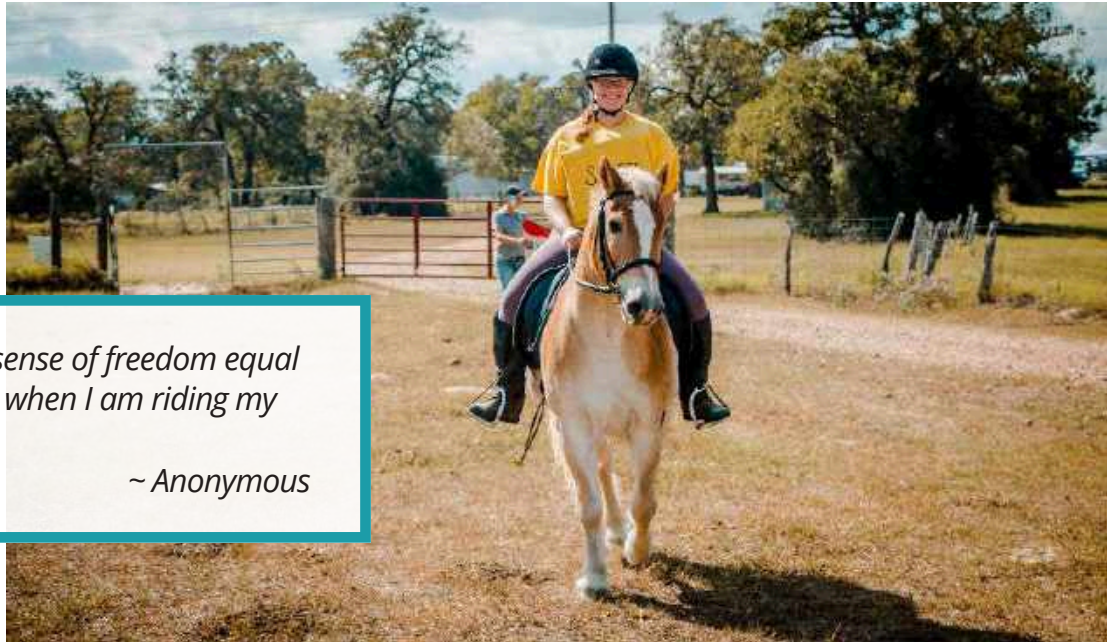
